

Mie Prefecture request Facilities for attracting visitors in areas where Priority Preventative Measures are taken to shorten their nighttime business hours

Details of the request

The following facilities (except for restaurants, etc.) **are requested to shorten their business hours until 20:00** in areas where special priority measures are to be taken for Priority Preventive Measures.

Request period

From **Sunday, May 9, 2021** to **Monday, May 31, 2021**

*You are basically required to cooperate with the request for shorter hours during the entire period mentioned above, but if you cooperate in shortening your business hours at least from May 14 to May 31, you will be eligible for the cooperation money.

Target area

Kuwana City, Inabe City, Kisomisaki Town, Toin Town, Yokkaichi City, Komono Town, Asahi Town, Kawagoe Town, Suzuka City, Kameyama City, Iga City, Nabari City

*Not all of Mie Prefecture.

Target Facilities

*Please refer to the Appendix for details.

(1) Theaters, hotels, or inns (limited to the portion used for meetings) exceeding 1,000m².
Sports facilities, amusement facilities, sales of goods and services (excluding daily necessities and services)

(2) Tenants, etc., who lease a part of the above *Businesses operating businesses except for restaurants

Mie Prefecture cooperation money for requesting shorter hours at visitor-attracting facilities

Amount paid

*Duplicate payments cannot be made with the Mie Prefecture Shortened Hours Request Cooperation Money for restaurants, etc.

- (1) Large-scale facilities, etc. 200,000 yen/day per 1,000m² x A x number of shortened days
- (2) Tenants, etc. 20,000 yen/day per 100m² x A x number of shortened days

A: Shortened hours / original business hours

Example: In case a 3,000 m² department store that is open from 10:00 to 22:00 cooperates with a request to shorten hours to 20:00 for 21 days from May 11 to May 31.

$200,000 \text{ yen} \times (3,000 \text{ m}^2 / 1,000 \text{ m}^2) \times (2 \text{ hours} / 12 \text{ hours}) \times 21 \text{ days} = 2,100,000 \text{ yen}$ will be paid.

Main requirements for payment

1. The business must operate a facility that fully cooperates* in shortening the hours of operation to 20:00 at the facility subject to the request.
*Full cooperation means that you will cooperate in shortening the hours of operation for **at least the entire period from May 14 to May 31.**
2. The business must be operating the subject facility **beyond 20:00 as of May 6.**
3. The facility must be located **within the target area of the request.**
4. **Adherence to industry-specific guidelines.**

The general flow of application

(1) Check the contents of the request and the requirements for payment.

(2) Conduct business in response to requests for shorter hours (shorten business hours after 20:00.)

Please take photos of the store, the exterior and interior of the store, etc. to prove the shortened hours of operation.

After publication of application guidelines

Please wait for the application guidelines as they are being prepared. (It will be posted on Mie Prefecture website in early June.)

The latest information will be updated on Mie Prefecture website, so please check there.

Please read the application guidelines carefully and prepare the necessary documents before submitting your application.

(3) Preparation of necessary documents

In addition to the application form and written pledge (form), please prepare documents that objectively show the actual status of the business (such as copies of tax returns) as attachments.

(4) Check the required documents based on the check sheet.

Please use the checklist to make sure that all the necessary documents are in order.

(5) Application (by mail)

*If the documents are incomplete or if the actual business status cannot be objectively confirmed from the submitted documents, the cooperation money may not be provided.

Documents required for application

The application guidelines are currently being prepared. (It will be posted on Mie Prefecture website in early June.)

Please read the application guidelines posted on Mie Prefecture website carefully and prepare the necessary documents before submitting your application.

To apply for the cooperation money, the following documents are required in addition to the application form, written pledge (form), etc. as specified in the application guidelines.

(1) A copy of the tax return

(2) Documents that objectively show that the facility is in operation.

(3) Documents confirming the area of the facility

Drawings, tenant contracts, etc.

(4) Documents confirming the shortened business hours

Please take a picture of the posters of the stores announcing the shortened business hours and print it out.

Please take a picture of your store entrance, etc., to show that you have made this information known to the public.

(5) Documents that confirm normal business hours.

Materials that show normal business hours as of May 6. Items that are known to the public externally, such as store signs.

(6) Photographs of the exterior and interior of the store

Please attach a photo taken within the last one month.

Please take multiple photos of the interior of each floor.

(7) Permits required for conducting business

Please submit only if applicable.

(8) Documents that can be used for identification

Please attach a copy of your driver's license or other photo ID.

(9) Copy of bankbook

Please attach the front side of the bankbook and the first and second pages that show the account number and
