This applies senior high school students whose parents are receiving welfare public assistance from the government and whose income are subject to municipal tax-exemption.

2024 School Allowance for Senior High School Students (National and Public School)

◆0verview of the Benefits

The High School Supplemental Scholarship Fund system provides grants (no repayment required) to low-income households with children who attend public high school in order to support educational costs other than tuition.

◆ Applicable to households who meet the following requirements below as of July 1, 2024

- Households with high school students who are eligible to receive the High School Tuition Support
 Fund system (grants for tuition)
 (not applicable to students who are on leave of absence as of July 1, students attending the School
 for Children with Special Needs and students under the care of orphanage facilities).
- Parents whose address are registered in Mie (not applicable to parents whose address are registered outside the country)
 - However, if one of the guardians is living abroad as of January 1, 2024, the household is not eligible for the benefit because a taxation certificate for the fiscal year 2024 will not be issued. (Households receiving occupational assistance as of July 1 are eligible to receive this benefit.)
 - If the address of the guardian or the corresponding person is outside of Mie Prefecture, please contact the prefecture in which they have their certificate of residence.
- Parents of the students (generally, all those who have custody of their children) who are receiving welfare public assistance from the government or those parents who are exempted from paying the local tax impose by the municipal office as of 2024. (Person with zero income percentage can apply, even if there is per capita rate of municipal tax)
- If a household is on welfare and does not receive livelihood assistance (high school tuition), you can apply as a tax-exempt household.

◆How to Apply

<u>For households who meet all the above requirements, please ask the school for application. Application form will be given by the school.</u>


XIf there are more than one senior high school student in one household, you need to apply for the benefits separately.

◆Where to submit application documents

Please submit to school representative.

 You cannot apply for both 'application for households with sudden financial situation change" and 'general application' at the same time.

◆Benefits

- Once a year ($\frac{1}{2}$) benefits will be transferred to the bank account ($\frac{1}{2}$) stated in your application
 - X1 The number of times the students will receive this benefits will have a total of 3 times (4 times for those students who are under the Part-time and Correspondence Course)
 Students in advanced course will be paid up to twice. (In case of a one-year program, it will be paid once.)
 - 💥 In case the benefits are entrusted to the school, payment will be directly transferred to the school
- The amount of the benefit may change according to household situations (refer to the chart below)

- The amount of the second benefit will be the amount of the benefit shown on the left minus the amount of the first benefit.
