## The "eligibility requirements" for the re-enrollment will change from the 2026 Prefectural High School Entrance Examination (held in March 2026).

Why

How will it

In order to promote education that leaves no one behind, we have revised the eligibility requirements for the re-enrollment, which is the last opportunity to take the prefectural high school entrance exam, so that as many people as possible can study in high school.

## New eligibility requirements

Those eligible to apply for the re-enrollment must meet the following two requirements (1) and (2).

① Those who have not passed the entrance examination for a Mie Prefectural High School. However, those who have passed the examination but have submitted "a notice of decline of admission" can apply.

② People who have not been accepted to any national or private high schools (including technical colleges) in or outside the prefecture. Although people who have been accepted but have not yet completed the "final admission procedures" can still apply.

However, people who have completed the "final admission procedures" can still apply if they meet any of the following requirements.

- People applying to high schools with vocational, general, physical education, or arts specialization courses
- People who have unavoidable circumstances and whose circumstances are recognized by the principal of their junior high school or other schools

Q 1 What is the "final admission procedure"? A For private high schools in the prefecture, this is the admission procedure that is carried out after the announcement of successful applicants in mid-March or later, by attending the convening day for prospective students. For other high schools (outside the prefecture, etc.), this is the procedure that guarantees admission to each high school.
Q2 Which schools offer vocational, Integrated, physical education, and arts specialization courses?
A The following high schools are eligible (as of 2024):

Q3 What kind of circumstances are considered "unavoidable circumstances" that the principal of a junior high school or other schools recognizes?
<ul> <li>A Since it is anticipated that due to financial circumstances, it will be difficult for you to continue your studies at the school where you have completed your "final admission procedures," your application will be accepted with the following circumstances taken into consideration <ul> <li>If you are receiving financial support from the national or prefectural/municipal government, such as a household receiving public assistance, a household not subject to resident tax, or a household eligible for the school assistance system (needing assistance or semi-needing assistance)</li> <li>Those who have been accepted for a Mie Prefecture high school scholarship or whose household income meets the loan requirements</li> <li>When a sudden change in household finances causes the household income to meet the loan requirements for the Mie Prefecture High School Tuition Support Grant (emergency grant)</li> </ul> </li> </ul>
